1.4.2 – How the feedback obtained is being analyzed and utilized for overall development of the institution? (maximum 500 words)

Feedback Obtained

A set of questionnaire consisting of 25 questions were designed to make a survey of institutional feedback during the session 2018. The main sections were a. Course content b. Teaching learning process c. Curriculum, syllabus evaluation process. d. Administration. e. Library sports and others. The activities of institution in the above sections have been analyzed to create a quality profile for the year (2018) in relation to institutional goals and visions. The result would enable the institution to create a quality index profile. Students play central role in both internal quality assurance and external quality assurance. Students have to be given a voice at various decision making process, formulating learning and teaching. To develop an effective channel of communication between students and administration feedback system is very helpful. In the session 2018, the institution collected feedback from around 256 students of different streams. 1. Students were asked questions related to course content, communication skill and knowledge and class discussion by teachers. Approximately 77 of students rate teachers performance high. Teachers cover the entire syllabus. They have sound knowledge of subjects and effective communication skill. Teachers discuss topics in detail. 11 of students were not satisfied with teachers communication skill and knowledge of subjects. Rest of 12 students had not their opinion about asked questions. 2. In the teaching learning process, students were asked questions about completion of course in time, use of modern teaching aids, guidance and counseling in academic and non academic matters, attention to weaker students and class assignments. About 78 of participating students were satisfied with teacher performance while 13 students were not satisfied with their performance while 19 students did not expressed their opinion. 3. Students were asked question related to curriculum, evaluation, administration, library and extracurricular activities. Approximately 67 of students were very satisfied with questions asked in the questionnaire, 19 were satisfied with questions asked while the rest percentage of students were unsatisfied with related questions.
